01. INTRODUCTION

The Uttarakhand State Co-operative Bank Ltd.(here after will be referred as USCB), an apex Co-operative Bank registered under Uttarakhand Co-operative Societies Act, 2003 invites Sealed bids on behalf of Managing Director, USCB, Ltd. under **Two Bid System** i.e. Technical Bid and Financial Bid from reputed, experienced and financially sound Manpower resources Companies/Firms/Agencies for providing services of Manpower and Security guards in the entire premises of USCB Ltd, for a period of one year from the date of Contract.

Desirous companies/firms/agency may obtain tender documents on request in writing from Dispatch Section, USCB Ltd, Haldwani on all working days between 10:00 Hrs to 17:00 Hrs before the due date on payment of Rs.1000/- (non- refundable) in form of Demand draft from any Banks drawn in the favour of Uttarakhand State Co-operative Bank Ltd." Haldwani payable at Haldwani.

03. EMD

The interested Companies/firms/Agencies may put the tender document complete in all respects along with Earnest Money Deposit (EMD) of Rs.1,50,000/- in the form of Demand draft, Fixed Deposit Receipt, Bank Guarantee from any of the Commercial Banks drawn in favour of "Uttarakhand State Co-operative Bank Ltd." Haldwani payable at Haldwani and other requisite documents in the Tender Box kept near Security Cabin of Uttarakhand State Co-operative Bank Ltd Administrative Office Nainital Road , Haldwani .

The bid securities of the unsuccessful bidders would be returned to them at the earliest after expiry of the final bid validity and latest on or before the 30th day after the awarded of the contract. The bid security is to remain valid for a period of forty-five days beyond the final bid validity period. No interest shall be payable

on EMD. Successful tenders in the event of the contractor failing to comply with any provision of the contract, EMD/Security Deposit shall stand forfeited.

04. PERFORMANCE SECURITY DEPOSIT

The successful bidder shall have to deposit a Performance Security Deposit of the 10% (approx.) of the total amount of order within 20 days of the receipt of the formal order. 08. Submission of Bid

- (i) The bid shall be written in English only.
- (ii) The bid prepared by the bidder shall comprise of (i) technical bids and (ii) price bid.
- (iii) Bid may be submitted in the following manner:

Envelope No. 1- Shall contain all the information and documents in the same serial order as shown in the technical bid. The complete document should be numbered chronologically. On the top of envelope must be suprescribed "Technical Bid". Shall also contain the bid EMD.

Envelope No.2- Shall contain the rates/prices of the duly filled in (schedule of rates) and signed and stamped. On the top of envelope must be suprescribed "Price Bid".

(Please note that the price should not be indicated in any of the documents enclosed in envelope 1).

- (iv) All the envelopes must be suprescribed "Tender for Providing Services of Security Guards" with due date and time and shall be sealed in third envelope of bigger size addressed to The Managing Director, Uttarakhand State Cooperative Bank, Ltd Nainital Road, Haldwani-263139. - (v) Incomplete and conditional tender will be rejected.
- (vi) All the envelopes shall indicate the name and address of the bidder to enable the bid to be returned, if required.
- (vii) No other method/means of submission of bid except as stated above shall be acceptable. All the documents submitted in the bid must be legible and self attested. Otherwise the bid is likely to be rejected. Each page of technical and price bid should be duly signed & stamped.

- (x) No conditional discounts will be allowed.

SCOPE & DESCRIPTION OF WORK AND GENERAL INSTRUCTIONS FOR BIDDERS

The contract is initially for one year and likely to commence from March 2019 till the completion of one year. The period of the contract may be further extended for one year after the completion of contract on mutual agreement. The contract may be curtailed / terminated before the contract period owing to deficiency in service or substandard quality of the manpower/guards deployed by the selected Company / Firm /Agency. This office also reserves the right to terminate the contract during its currency at any time after giving one month notice to the successful bidder.

- 1. The unskilled manpower should be able to read and write Hindi and also be able to read addresses and names in English. They should be at least H.Sc. pass from a recognized board and have knowledge of computer operations. The security guards should be H.Sc. pass from a recognized board, able to read Hindi and addresses in English. He should have sound health and experience as security guard. Should be able to operate computer for gate pass.
- 2. The security personnel must be duly trained in Fire Safety Operations. They should be trained to operate various fire control equipments, if any, installed at check gate. The Service provider shall produce proof that the personnel provided have been trained in fire safety operation from the organized institutions.
- 3. The nature of service for the unskilled, semi-skilled type of manpower and security guards shall include but not be limited to the following activities.

Security Guards

- a) He should have ability to monitor CCTV.
- b) He should be physically fit and mentally alert.
- c) He should be able to understand the security requirements of UTTARAKHAND STATE CO-OPERATIVE BANK LTD. Centre.
- d) He should be able to keep vigil and protect the assets of UTTARAKHAND STATE CO-OPERATIVE BANK LTD. Centre.
- e) He should be able to operate computer for gate pass.
- f) He should not be age of more than 50 years.

TERMS AND CONDITIONS

- 1. The contract shall initially be for one year unless it is curtailed or terminated by this office owing to deficiency of service, sub-standard quality of manpower deployed, breach of contract, reduction or cessation of the requirements of work.
- 2. The Centre initially will have manpower for work in the Centre & will hire admin & other temporary staff on consolidated salary as per the mutual agreement.
- 3. The contract shall expire after one year from commencement of the contract unless extended further by the mutual consent of contracting agency and this office.
- 4. The contract may be extended, on the same terms and conditions for a further period not exceeding one year. The modification of the rates shall be subject to the variation of statuary levies and contributions and revision of daily minimum wages prevailing at the time of the extension.
- 5. This office reserves right to terminate the contract during entire period after giving one months notice to the contracting agency. The contract will remain valid for one year or the period specified in the letter communicating the acceptance, whichever is earlier, unless terminated earlier by the Centre.
- 6. The Successful bidder shall not be allowed to transfer, assign, pledge or sub-contract its rights and liabilities under this contract to any other agency without the prior written consent of this office.
- 7. The Successful bidder will be required to pay minimum wages to the manpower supplied as prescribed under the Minimum Wages Act notified from time to time. The Successful bidder will maintain proper record as required under the Law / Acts.
- 8. The requirement of this office may further increase or decrease during the period of contract and the Successful bidder would have to provide additional manpower, if required on the same terms and conditions. The requirement of manpower is optional at present which may increase or decrease from time to time and this office also reserves it right not to engage any manpower/security guard if so warranted.
- 9. The Successful bidder will be bound by the details furnished by him / her to UTTARAKHAND STATE CO-OPERATIVE BANK LTD., while submitting the bid or at subsequent stage. In case, any of such documents furnished by him / her is found to be false at any stage, it would be deemed to be a breach of terms of contract making him / her liable for legal action besides termination of contract.
- 10. An affidavit to the effect shall be provided by the contractor that no case is pending with the police against the Proprietor/Firm/Partner or the Company (Service Provider) and the Service Provider has not been blacklisted.
- 11. The Successful bidder shall ensure that the manpower deployed in The Office of UTTARAKHAND STATE CO-OPERATIVE BANK LTD. Centre conforms to the technical specifications, age and language skills prescribed in the Tender Document.
- 12. The manpower employed by the agency shall be required to work normally from Monday to Sunday from 0900 hrs. to 1800 hrs. with a lunch break of ½ hour from 1300 hrs. to 1330 hrs. The manpower may also be called upon to perform duties on Saturday, Sunday and other gazetted holidays, if required. The manpower, if deputed for any official work outside the office within Haldwani, shall not be entitled for any other emoluments except only the actual bus fare for the purpose.

- 13. The Successful bidder shall furnish the following documents in respect of the individual Manpower who will be deployed by it in this Department before the commencement of work:
 - (a) List of Manpower short listed by agency for deployment at UTTARAKHAND STATE CO-OPERATIVE BANK LTD. Centre, containing full details i.e. date of birth, father name, marital status, address, photograph, identification proof etc;
 - (b) Bio-data of the persons.
 - (c) Certificate of verification of antecedents of persons by local police authority.
- 13. The agency shall be directly responsible for any/all disputes arising between it (agency) and its employees and keep the institute indemnified against all losser, damages and claims arising thereof. In this connection, the agency shall submit the duly signed Indemnity bond (Annexure-V).
- 14. The bidding company shall provide identity cards to the personnel deployed in this office carrying the photograph of the personnel and personal information as to name, DOB, age and Identification mark etc.
- 15. The service provider shall ensure that any details of office, operational process, technical know-how, security arrangements, and administrative/organizational matters are not divulged or disclosed to any person by its personnel deployed in this office.
- 16. The service provider shall ensure proper conduct of his personnel in office premises, and enforce prohibition of consumption of alcoholic drinks, paan (including Paan masala), tobacco chewing, smoking, loitering etc without work.
- 17. No Bonus, washing allowance, uniform allowance etc. will be entertained by UTTARAKHAND STATE CO-OPERATIVE BANK LTD. and contractor has to bear all such expenses.
- 18. The service provider has to produce to UTTARAKHAND STATE CO-OPERATIVE BANK LTD. copy of EPF, ESI etc. to paid to Govt. while claiming the bill.
- 19. The person deployed shall be required to report for work as per the prescribed timings. In case, person deployed is absent on a particular day or comes late / leaves early on three occasions, one day wage shall be deducted. In case of repetition of such instances, clause 18 of terms and condition will be applicable.
- 20. The contractor shall endeavor to provide the service of the same manpower as deployed at the beginning of the contract, throughout the period of contract, except in extra ordinary circumstances like person leaving the job or person being asked to be replaced by this office. Not more than one change per person deployed limited to three of all the person deployed shall be permitted unless such changes are justified in view of Managing Director. If the change exceeds the limit mentioned above and are not justified then a penalty of Rs. 200 per additional change will be imposed.
- 21. The agency shall designate a coordinator, out of the deployed personnel, who would be responsible for immediate interaction with this office, so that optimal services of the persons deployed by the agency could be availed without any disruption.
- 22. The selected agency shall provide a substitute in the event of any person remaining unauthorised absent to more than two days for any reason. Delay by the Agency in providing a substitute after expiry of two days absence shall attract liquidated damages @ Rs.500 per day per person plus applicable daily remuneration (per such

- case) starting from the day from which the person has been absent on the service providing agency, besides deduction in payment on pro-rata basis.
- 23. For all intents and purposes, the Successful bidder shall be the "Employer" within the meaning of different Labour Legislations in respect of manpower so provided and deployed in this office for contractual services. Bidders shall indemnify the UTTARAKHAND STATE CO-OPERATIVE BANK LTD. from all liabilities whatsoever arising out of such deployment at any stage of contract or thereafter. For any damages, losses, claims, financial or other injury to any person deployed by service providing agency in the course of their performing the functions/duties, or for payment towards any compensation.
- 24. The Successful bidder shall be solely responsible for the redressal of grievances/ resolution of disputes relating to person deployed by the agency. This office shall, in no way, be responsible for settlement of such issues whatsoever. This office shall not be responsible for any damages, losses, claims, financial or other injury to any person deployed by service providing agency in the course of their performing the functions/duties, or for payment towards any compensation.
- 25. It will be the responsibility of the contractor to meet the transportation, food, medical and any other requirement of contractor's manpower for carrying out the contract works. Centre will have no liability in this regard at any stage.
- 26. The man power deployed by the contractor shall not have any claims of Master and Servant relationship nor have any principal and agent relationship vis a vis UTTARAKHAND STATE CO-OPERATIVE BANK LTD.. For all practical purpose the bidder shall be employer of such manpower provided to Centre to perform assigned task.
- 27. The man power deployed by the contractor for the contract shall not be entitled for claim, pay, perks and other facilities which may be admissible to casual, ad-hoc regular / confirmed employees of this office, during the currency or after expiry of the contract. In case of termination of the contract also, the persons deployed by the contractor shall not be entitled to have any claim for absorption or relaxation for absorption in the regular / otherwise capacity in the UTTARAKHAND STATE CO-OPERATIVE BANK LTD. This should be communicated to all the persons deployed in this office by the contractor.
- 28. Payment shall be made only to the contractor on monthly basis as per actual services. The contractor has to raise invoices in the first week of the next month for the services rendered in the previous month.
- 29. No sub-contracting is permissible. The near relatives of all UTTARAKHAND STATE CO-OPERATIVE BANK LTD. employees either directly recruited or on deputation are prohibited from participation in this tender. The near relatives for this purpose are defined as:
 - (d) Members of Undivided family,
 - (e) Are husband and wife,
 - (f) The one is related to the other in the manner as father, mother, son (s) & son's wife (daughter-in-law), Daughter(s), & daughter's husband (son-in-law), brother(s) & brother's wife, sister(s) & sister's husband (brother-in-law).
- 30. The bidders should give a certificate (as per proforma attached in ANNEXURE-III) to the effect that none of his/her such relative is working in the Centre as defined above. In case of proprietorship firm the certificate will be given by the proprietor, for partnership firm certificate will be given by all the partners and in case of Limited company by all Directors of the Company. Any breach of these conditions by the company or firm or any other person, the tender/work will be cancelled and earnest

money/security deposit will be forfeited at any stage whenever it is noticed. The purchaser will not pay any damages to the company or firm or concerned person. The company or firm or the person will also be debarred for further participation in the concerned unit.

- 31. The Successful bidder will be responsible for compliance of all statutory provisions relating to Minimum Wages, Provident Fund, and Employees State Insurance etc. in respect of the persons deployed by it in this office.
- 32. Successful bidder shall deposit all taxes, levies, Cess etc. on account of service rendered by it to concerned tax collection authorities from time to time as per extant rules and regulations on the matter and produce such receipt to UTTARAKHAND STATE CO-OPERATIVE BANK LTD. Centre.
- 33. The Successful bidder shall maintain all statutory registers under the applicable Law. The agency shall produce the same, on demand, to the concerned authority of this office or any other authority under Law.
- 34. The Tax Deduction at Source (T.D.S.) shall be deducted as per the provisions of Income Tax Department, as amended from time to time and a certificate to this effect shall be provided to the agency by this office.
- 35.  - Fraudulent practice means a misrepresentation of facts in order to influence a procurement process or the execution of a Contract and includes collusive practice among Bidders (prior to or after Bid submission) designed to establish Bid prices at artificial non competitive levels and to deprive the UTTARAKHAND STATE CO-OPERATIVE BANK LTD. of the benefits of free and open competition.
 - "Corrupt Practice" means offering, giving, receiving or soliciting of any thing of value, pressurizing to influence the action of a public official in the process of Contract execution
- 42. LACK OF INFORMATION TO BIDDER: The Bidder shall be deemed to have carefully examined all contract documents to his entire satisfaction. Any lack of information

shall not in any way relieve the Bidder of his responsibility to fulfill his obligation under the Contract. Any query, whatsoever, in this regard must be put up and cleared in the pre-bid meeting.

- 43. CONTRACT OBLIGATIONS: After the award of the contract, if the Bidder does not fulfil contract obligations within stipulated time as well as quality then UTTARAKHAND STATE CO-OPERATIVE BANK LTD. reserves the right to cancel the contract and apply all remedies available to him under the terms and conditions of this contract.
- 44. Service Charges should be quoted in % (Percentage)
- 45. The requirement of this office may increase or decrease during the period of the contract.
- 46. The conditional bids shall not be considered and likely to be rejected in very first instance.
- 47. All entries in the bid form should be legible and filled clearly. If the space for furnishing information is insufficient, a separate sheet duly signed by the authorized signatory may be attached. No overwriting or cutting is permitted in the Financial Bid form. The cuttings, if any, in the Bid/ Bid application must be initialled by the person authorized to sign the bid.
- 48. The UTTARAKHAND STATE CO-OPERATIVE BANK LTD. Centre reserves the right to annul any or all bids without assigning any reason.
- 49. FORCE MAJEURE

If any time, during the continuance of this contract, the performance in whole or in part by either party or any obligation under this contract shall be prevented or delayed by reason of any war, or hostility, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts or act of God (Hereinafter referred to as events) provided notice of happenings, of any such eventuality is given by either party to the other within 21 days from the date of occurrence thereof, neither party shall by reason of such event be entitled to terminate this contract nor shall either party have any such claim for damages against the other in respect of such non-performance and work under the contract shall be resumed as soon as practicable after such event and may come to an end or cease to exist, and the decision of the UTTARAKHAND STATE CO-OPERATIVE BANK LTD. Centre as to whether the work have been so resumed or not shall be final and conclusive, provided further that if the performance, in whole or part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceeding 60 days either party may, at his opinion terminate the contract.

50. ARBITRATION

In the event of any question, dispute or difference arising under this agreement or in connection there with except as to matter the decision of which is specifically provided under this agreement, the same shall be referred to sole arbitration of the Registrar Co-operative Societies Almora Uttarakhand to the sole arbitration of the officer for the time being entrusted whether in addition to the functions by whatever designation such officers may be called (herein after referred to as the said officer) and if the Registrar Co-operative Societies Uttarakhand Almora or the said officer is unable or unwilling to act as such to the sole arbitrator, the agreement to appoint an arbitrator will be in accordance with the Arbitration and Conciliation Act, 1996. The award of the arbitrator shall be final and binding on the parties. In the event of such arbitrator to whom the matter is originally referred to, being transferred of vacating

his office or being unable to act for any reason whatsoever, Director or the said officer shall appoint another person to act as arbitrator with terms of the agreement and the person so appointed shall be entitled to proceed from the stage at which it was left out by his predecessors.

The arbitrator may from time to time with the consent of parties enlarge the time for making and publishing the award, subject to aforesaid Indian Arbitration and Conciliation act 1996 and the Rules made there under, any modification thereof for the time being in force shall be deemed to apply to the arbitration proceeding under this clause. The venue of the arbitration proceeding shall be the Office of the Registrar Co-operative Societies Uttarakhand Almora or such other Places as the arbitrator may decide. The following procedure shall be followed.

- In case parties are unable to reach a settlement by themselves, the dispute should be submitted to arbitration in accordance with contract agreement.
- There should not be a joint submission with the contractor to the sole Arbitrator.
- Each party should submit its own claim separately and may oppose the claim put forward by the other party.
- The onus of establishing his claims will be left to the contractor.
- Once a claim has been included in the submission by the contractor, a reiteration or modification thereof will be opposed.
- The "points of defense" will be based on actual conditions of the contract.
- The Arbitrator shall not entertain claims in the nature of ex-gratia payments, as these are not contractual.
- The question whether these conditions are equitable shall not receive any consideration in the preparation of "points of defense".
- If the contractor includes such claims in his submission, the fact that they are not contractual will be prominently placed before the Arbitrator.
- 51. The award of the sole Arbitrator shall be final and binding on all the parties to the dispute.
- 52. The Managing Director, UTTARAKHAND STATE CO-OPERATIVE BANK LTD. Centre reserves the right to withdraw/ relax any of the terms and conditions mentioned above so as to overcome the problem encountered by the contracting parties.
